

BURGER BATTLE 2021 - COMPETITION RULES

1. Organizers

The organizers of the Burger Battle competition are Lantmännen Unibake Ab Finland Oy and Food Camp Finland Oy. Other sponsors are Wihuri Oy Aarnio Metro-tukku, HKScan, Easyfairs Oy and Arla Pro.

2. Applicants

The competition is open for all professional chefs and cooks that are over 18-years old. The jury will choose eight semifinalists anonymously based on the submitted recipes and photos. Four contestants will move on to the final.

3. Application period

The application period for Burger Battle 2021 competition is 15.11.2020 – 18.6.2021. The application period ends 15.1.2021 at midnight. **The application form can be found here.** The applications sent after the application period will be disqualified. The applicant has full responsibility in applying to the competition in time.

4. Application period, semifinal and final

Application period :

Applicants may apply to the competition by filling out the application form here. All applicants send in their own artisan cheeseburger recipe and photo of their burger. The bun should be own baked. The recipes and pictures should be sent via application form until midnight on June 18, 2021. The jury will choose eight semifinalists anonymously based on the recipes submitted in the application forms. All contestants advancing to the semifinal will be informed by Midsummer 2021. The semifinalists will publicly be announced after this.

Semifinal:

The semifinal takes place at Fastfood & Café & Ravintola fair in Helsinki on the 13rd of October, 2021. All eight semifinalists will prepare two different types of burgers in front of the jury. One of the burgers will be prepared according to the recipe they applied with the own baked bun. The second one – vegetarianburger will be prepared using ingredients provided by sponsors and Landmän Unibake's buns. For the first burger, the contestants will bring their own baked burger buns.

The contestants are also allowed to bring their own sauce bases (e.g. mayonnaise) but the seasoning of the sauces will happen on site. All other ingredients for the first burger can be brought to the competition chopped and prepared. The semifinalists have 45 minutes in total to prepare both burgers.

Final:

Final Four contestants will move on to the final.

The task for the final competition will be announced to the finalists on the 13rd of October, 2021. The final takes place at Fastfood & Café & Ravintola fair in Helsinki on the 14th of October, 2021.

5. The jury

The jury consists of top professionals and sponsor representatives. It is led by the chairman of the jury Mika "Pikkis" Tuomonen – Social Burgerjoint. The chairman is involved in the judging and in the situation of a draw and lack of consensus, makes the final decisions.

6. Prizes

1. prize 4.000 €
2. prize 700 €
3. prize 300 €

All the semi-finalists will receive a certificate, and the first three, a separate diploma.

7. Responsibility

The competition's organizers are not responsible of any damage or costs the application and part taking in the competition or receiving the prize might cause. The organizers or sponsors are not held responsible for any possible injury or damage caused by the redemption or use of the prize.

8. Taxes

Finnish taxes and laws apply to the prizes given out in this competition. The competition's organizers are not responsible of any travelling and accommodation costs.

9. Privacy policy

The personal data of the participants will be processed in accordance with the terms of the Personal Data Act. By participating in the competition, each participant grants the organizers and sponsoring companies the right to use their names, recipes, recipe photos and photos where they appear in the competition's marketing purposes and communication on different media without separate consent or compensation.

10. Changing the rules
